WHAT IS CHARITY PLUS?

A program giving registered charitable organizations a 5% discount on purchases* they make at Calgary Co-op.

WHO IS ELIGIBLE FOR CHARITY PLUS CARDS?

To qualify, your organization must have a charitable registration number with the Canada Revenue Agency (CRA) and must be a Calgary Co-op member. A lifetime membership may be purchased at any Calgary Co-op food centre for \$1.

Non-profit groups not registered with the CRA are not eligible, but are welcome to apply for donations from Calgary Co-op as outlined in our Community Investment Program. Visit www.calgarycoop.com for details.

HOW DOES CHARITY PLUS WORK?

Present your Charity Plus card to the cashier at the beginning of your transaction. Your card will be scanned and eligible items will automatically receive an immediate 5% discount. Your total Charity Plus savings will be printed at the bottom of your receipt.

WHERE CAN CHARITY PLUS CARDS BE USED?

Charity Plus cards can be used at all Calgary Co-op food centres including stores in Airdrie, High River and Strathmore.

*WHAT IS NOT ELIGIBLE FOR THE CHARITY PLUS DISCOUNT?

The following items sold in our Food Centres are not included:

- Advertised Specials
- In-Store Specials
- Price Drop Sale Items
- Special Ticket Offers

The following purchases made at other Calgary Co-op stores are also not included:

- Home Health Care items
- Convenience Store Items
- Gas
- Liquor
- Tobacco
- Lottery
- Gift Cards
- Cannabis
- Prescriptions

* Additional items may be added to the exclusion list at any time.
