

## Campbell's & Calgary Co-op Contest RULES & REGULATIONS

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE CONTEST IS VALID ONLY TO RESIDENTS OF ALBERTA, CANADA (AND IS OPEN ONLY TO ELIGIBLE PERSONS, AS SPECIFIED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED.

This Contest is administered by Calgary Co-op Limited, doing business as Calgary Co-op ("**CCL**") and the Prize is provided by Campbell Company of Canada. CCL and Campbell Company of Canada are hereafter collectively referred to in these Rules as the "**Contest Entities**".

### 1. How to Enter

You will automatically be entered into the contest (the "**Contest**") when you use your Calgary Co-op Membership Card and you purchase 4 Campbell products listed on Schedule "A" (the "**Products**") in any of CCL stores operating as Co-op in Calgary, Alberta or at <https://shoponline.calgarycoop.com/> (a "**Store**") in one transaction during the Contest Period.

Each time you shop online or in a store during the Contest Period, provide your Calgary Co-op Membership Card at till and purchase 4 Campbell products (while supplies last) in a single transaction, your name will be electronically entered into the Contest. If you do not yet have a Calgary Co-op Membership Card, visit your local Calgary Co-op store to enroll for free.

### 2. No Purchase Necessary

No purchase is necessary to enter the Contest. Non-members or members using no purchase necessary method can enter by submitting an essay no longer than 500 words describing why they should win the contest along with which Calgary Co-op store is their primary food centre to:

All manual entry forms must be received at the above address by 11:59 PM MST, on **February 14, 2024**. Only one (1) manual entry form per envelope per day will be accepted. Mechanically reproduced entries will not be accepted. Manual entry forms will be subject to verification and will be declared null and void by CCL if the manual entry form is found to have been obtained outside legitimate channels of distribution as may be determined by CCL in its sole discretion.

CCL is not responsible for manual entry forms or automatic electronic entries which are lost, late, misdirected, damaged, incomplete, illegible, have insufficient postage, or are otherwise in any way not entered or eligible for the contest.

**3. Contest Period**

The Contest begins at store opening on **January 18, 2024 and** closes at 11:59 (MST) on **February 14, 2024** (the "**Contest Period**"). All purchases must be completed no later than the close of the Contest Period. Any purchases made or entry forms received after the date specified will be declared invalid and will not be eligible for the Prize draw.

**4. Prize Drawing**

On or about February 15, 2024, at approximately **(11:00)** (MST), a random draw from all entries received within the Contest Period will be conducted at the CCL head office in Calgary, Alberta. The odds of winning a Prize in this Contest are dependent upon the total number of eligible entries received.

**5. Prize**

There is 1 (one) prize of \$1000 in Calgary Coop gift cards. All gift cards are subject to retailer's terms and conditions.

The approximate retail value of the Prize is \$1000.

The Prize includes only what is specifically described and no other prize will be granted. Winner is not entitled to any monetary difference between actual Prize and the stated approximate value, if any.

**6. Prize Not Transferable and No Substitutions**

Prize must be accepted as awarded. No cash equivalent or exchange of Prize is permitted. All aspects of the Prize are non-transferable until awarded. CCL reserves the right to make a substitution for the Prize, which in the opinion of CCL, is of similar kind or value, without prior notice. Any and all expenses, costs and all local, provincial or federal taxes or sales taxes resulting from winning and accepting the Prize are the responsibility of the winner.

**7. Notification**

The entrants whose names are drawn will be contacted by telephone using the telephone number noted on the manual entry form or on the current Co-op Membership records held by CCL. CCL will provide Campbell Company of Canada or its designated representative with the contact information for only to contact selected entrants. Attempts will be made to contact each selected entrant during regular business hours for a period of three (3) business days after the date of the Prize draw. If a selected entrant cannot be contacted, fails to respond to any telephone messages left by Campbell Company of Canada or its designated representative within five (5) business days from Prize draw, or the Prize is refused, then he/she will forfeit any right to the Prize and CCL may, in its sole discretion, select an alternate. The winner will receive prize via mail or in person.

It is the entrant's responsibility to keep his/her email address, mailing address and phone number current with CCL.

In accordance with Calgary Co-op's Privacy Policy, Campbell Company of Canada or its designated representative is acting in the capacity of an information manager and will not retain the contest winner's details beyond the stated purpose of contacting winner, nor will Campbell

Company of Canada use the information for their own purposes such as additional marketing of Campbell Company of Canada products.

**8. Distribution of Prize**

Selected entrant will receive prize via Campbell Company of Canada or its designated representative no later than ten (10) business days after the date of the Prize draw.

**9. Eligibility**

The contest is only open to residents of Alberta, Canada who are the age of majority. To be eligible to win a Prize in this Contest, you must be a Co-op Member.

**10. Contest Rules & Regulations**

By participating in the Contest, the entrants unconditionally agree to be bound by the Contest Rules & Regulations. The entrants further agree to be bound by the decisions of CCL regarding the Contest Rules & Regulations or in any way relating to this Contest, as may be determined by CCL in its sole discretion, which will be final and binding in all respects.

**11. Privacy / Use of Personal Information**

All personal information of the entrants collected through the Contest ("**Personal Information**"), such as their name, address, telephone number, e-mail address and age is collected for the purposes of administering and promoting this Contest and CCL. Each entrant, by entering the Contest, consents to and grants CCL the right to collect, use and disclose their Personal Information for the purpose of administering and promoting the Contest. and CCL according to CCL's Privacy Policy at [www.calgarycoop.com/contests](http://www.calgarycoop.com/contests).

**12. Skill-Testing Question**

Before being declared a Prize winner, the selected entrant must successfully answer without assistance or mechanical aid, a time-limited mathematical skill-testing question as a condition to receiving the Prize.

**13. Disqualification**

Administrator reserves the right, in its sole discretion, to disqualify any selected entrant who:

- (a) cannot be reached by telephone or has not responded to telephone messages left within five (5) business days of the Prize draw.

- (c) has not correctly answered the skill-testing questions within the allotted time;

- (e) has not signed the Declaration, Release and Waiver Form in the form required by (Vendor) within ten (10) business days of the Prize draw;

- (f) for any reason whatsoever is unable or does not wish to accept the Prize as awarded.
- (g) is not the age of majority in the province in which the Contest is held.
- (h) is not eligible by law; or,
- (i) is deemed by the Contest Entities, in their sole discretion, to be ineligible, disqualified, or in non-compliance for any reason whatsoever.

- (b) the entrant's participation in any Contest-related activity;
- (c) the entrant's acceptance, use, misuse or any other matter in relation to the Prize;

- (e) the failure of Administrator to receive a selected entrant's response for any reason whatsoever;
